MEMBERSHIP PRICING SCHEDULE and GUIDELINES
EFFECTIVE MARCH 1, 2012

The following are the final pricing for membership to ReelClipsTV.com movie service. This pricing is in accordance with the final agreement as approved by the licensing movie studios namely:

- Warner Bros. Home Studios
- NBC/Universal Studios
- Walden Media Corporation
- The Weinstein Company and
- Lionsgate

In order to conform to the terms and agreements entered by ReelClipsTV Corporation with the above mentioned movie studios, the following are the membership subscription terms and plans available to users of ReelClipsTV.com movie service.

SUBSCRIPTION PLANS

1. Bronze Membership Plan :

- a. Members can watch up to **three (3) free new release movies per calendar month**, plus unlimited access to the online streaming movie catalog.
- b. Members are allowed to rollover one (1) unused new release movie to be added to the next month's subscription.
- c. **Cost: \$6.99/month automatically charge to credit card on file or using paypal account.**
- d. **Extra movie rental will be \$4.99 per movie.**

2. Silver Membership Plan:

- a. Members can watch up to **five (5) free new release movies per calendar month**, plus unlimited access to the online streaming movie catalog.
- b. Members are allowed to rollover two (2) unused new release movies to be added to the next month's subscription.
- c. **Cost: \$12.99/month automatically charge to credit card on file or using paypal account.**
- d. **Extra movie rental will be \$3.99 per movie.**

3. Gold Membership Plan:

- a. Members can watch up to **nine (9) free new release movies per calendar month**, plus unlimited access to the online streaming movie catalog.
- b. Members are allowed to rollover three (3) unused new release movies to be added to the next month's subscription.
- c. **Cost: \$19.99/month automatically charge to credit card on file or using paypal account.**
- d. **Extra movie rental will be \$2.99 per movie.**

SUBSCRIPTION TERMS

- A. **New Release Movies** are movies that were released on DVD up to six (6) months from initial DVD release.
 - a. **Example:** If the movie "DRIVE" was released on DVD on 09/01/2011, the movie will be considered as New Release Movie up until 03/01/2012.
 - b. After the New Release timeframe has elapsed, the movie will be automatically added to the Streaming Movie Catalog and will be available for 1-year from the date of release or until instructed by Movie Licensing Studios to remove from our streaming catalog whichever comes first.
- B. Users can only rollover movies on a monthly basis. Unused movies will only be rollover from the previous month.
 - a. **Example:** If the current month is February, only unused movie credits for February will rollover to March. Any unused credits and rollovers prior to February will be lost and removed from your credit count.
- C. All registered members must have their current credit card information registered with their account, or paypal can be used in lieu of the credit card. This will be used for processing your monthly membership fees and will automatically be processed via PayPal payment processing service on a monthly basis and every first (1st) of the month.
- D. If payment for monthly membership is not processed successfully with the currently registered payment method, ReelClipsTV.com will automatically send you an email and will put your account on hold until payment has been successfully processed. When your account is put on hold, you will still have access to all services and functionalities of ReelClipsTV.com except the ability to watch movies.
- E. Cancellation of membership account can be done by sending an email using your registered email account to cancel@reelclipstv.com. No refunds will be issued for all membership charges and you will be responsible for any excess charges beyond what your regular membership covers.

All paying members are entitled to the following benefits, and are limited only by the rules set forth in the "SUBSCRIPTION TERMS" section.

1. Unlimited access to ReelClipsTV.com website.
